Applicants will be assessed on the following criteria:

- **Academic Record**
- **Performance in the following mandatory tests:**

1. SAT (with Essay) or ACT (with Essay); and
2. The Law Admission Test (administered by the HEC)

In addition to the SAT (with Essay) /ACT (with Essay) all applicants of the BA-LL.B Programme must take the Law Admission Test. The Law Admission Test is a requirement

set by the Honorable Supreme Court of Pakistan for admission in the LUMS BA-LL.B Programme.

Financial Support

Admission to all programmes is purely on merit and independent of students' ability to pay the related tuition fees. Once a student has been admitted to a programme, there are several mechanisms in place to provide financial support based on need and merit. All awards are reassessed each academic year based on performance, need, available resources and prevailing University policies. LUMS is committed to providing as much financial assistance as possible within the limits of its available resources. Nevertheless, the University may not be able to meet all requests for financial assistance, and it is strongly recommended that applicants secure as much of their own funding as possible.




The BA phase of the degree is interdisciplinary in nature and exposes students to a wide range of disciplines offered at other Schools. Twenty-two core law subjects are taught in the LL.B phase during the last three years, making the students well-rounded law professionals who can contribute more meaningfully to society.
