## MBA, EMBA & MS-SDSB Fee Refund Policy FY 2025-26

## 1. Admission Cancellation

• In case an applicant's admission is cancelled by LUMS due to any reason including failure in meeting the requirements mentioned in the offer letter, he/she shall be entitled to get refund for tuition fee, semester registration, security, SOP, reading material and hostel/residence fee refund; however, admission fee will not be refunded.

## 2. Separation Refund Policy

- If a student is separated from the program by the university for academic reasons and has deposited the dues for the next semester, all such dues deposited will be refunded.
- If a student is separated from the program because of disciplinary reasons or reasons other than academic, the dues deposited by him/her for the current semester will not be refunded. However, if for some reason, the decision is delayed till the next semester and the student has already paid the dues for the next semester, such dues will be refunded.

## 3. Withdrawal from the Program:

- In case a new student finds it necessary to withdraw from the Program before the commencement of classes, he/she must inform the Office of Admissions (<a href="mailto:admissions@lums.edu.pk">admissions@lums.edu.pk</a>) in writing.
